

The Galilee Community Development Corporation (GCDC) was established in November of 2003, as a Maryland tax exempt, non-profit organization.

The first Board was tasked with addressing housing needs of the residents of Prince George's County and to keeping abreast of other community development projects.

The GCDC purchased a house which was refurbished and made available for rent. The GCDC worked with families to overcome financial indebtedness and build credit to increase their homeownership potential.

The house has since been renovated and sold.
